### WSF WORLD CHAMPION MUTTON BUSTIN' RELEASE OF LIABILITY AND INDEMNITY AGREEMENT

I, the UNDERSIGNED, hereby represent and warrant that I am the parent or guardian of the Minor Contestant named above "MINOR CONTESTANT" and that I have the full power, authority, capacity, and right, without limitation, to execute, deliver, and perform this release. In consideration of the MINOR CONTESTANT being permitted to enter the Wyoming State Fair Mutton Bustin' competition ("EVENT"), I the UNDERSIGNED, acknowledge and agree to all of the following terms of this Release Form.

**Acknowledgement and Assumption of Risk:** I, the UNDERSIGNED, understand and acknowledge that rodeos and related livestock events are dangerous activities and that participation in a rodeo or related livestock event exposes the participant to substantial and serious hazards that may result in property damage, personal injury, or death. I, the UNDERSIGNED, expressly acknowledge that the participation of the MINOR CONTESTANT will expose the MINOR CONTESTANT to such hazards, and assume full responsibility for and risk of bodily injury, death, and property damage arising from MINOR CONTESTANT'S participation in the EVENT due to negligence of the State of Wyoming, the Wyoming State Fair, and each of its subsidiaries and the employees and agents of each such entity ("RELEASEES").

**Release and Indemnity:** I, the UNDERSIGNED, hereby releases, hold harmless, and indemnify the RELEASEES, from liability for any and all property damage, personal injuries, death, or other claims arising from the above named MINOR CONTESTANT'S participation in the EVENT, even if the property damage, personal injury, or death is determined to have resulted from the negligent acts or omissions of the RELEASEES.

**Covenant Not to Sue:** I, the UNDERSIGNED, covenant that shall not now or at any time in the future, directly or indirectly, commence or prosecute any action, suit, or other proceeding against the RELEASEES, their officers, directors, employees, agents, assigns or affiliates for damages of any type arising from participation of the MINOR CONTESTANT determined to have resulted from the negligent acts or omissions of the RELEASEES.



Release of Photography: The UNDERSIGNED, hereby grants permission to the Wyoming State Fair to use the MINOR CONTESTANT'S name and any photographs or other likeness of the MINOR CONTESTANT in connection with promotions of the event in which the MINOR CONTESTANT participated and other events of the Wyoming State Fair.

Each of the undersigned expressly agrees that this Release of Liability and Indemnity Agreement (Agreement) is intended to be as broad and inclusive as is permitted by Wyoming law and that if any portion of this Agreement is held invalid, the rest of this Agreement shall continue in full legal force and effect.

EACH OF THE UNDERSIGNED HAS READ AND VOLUNTARILY SIGNS THIS AGREEMENT, and further agrees that this Agreement represents the entire and integrated Agreement between the parties and supersedes all prior negotiations, representations, and agreements, whether written or oral. Wyoming law shall govern this Agreement, and the State of Wyoming and the Wyoming State Fair expressly reserve their sovereign immunity. Venue for any dispute arising out of this Agreement shall be the First Judicial District Court, Laramie County, Wyoming.
