WYOMING STATE FAIR \$10,000 FIGURE 8 RACES RELEASE, WAIVER OF LIABILITY, AND INDEMNITY AGREEMENT

IN CONSIDERATION of being permitted to enter for any purpose the RESTRICTED AREA (herein defined as the area to which admission to the general public is prohibited), the undersigned, for themselves, and their personal representatives, heirs, and next of kin:

1. HEREBY RELEASES, WAIVES LIABILITY, AND COVENANTS NOT TO SUE, the State of Wyoming, the Wyoming State Fair Board, Wyoming State Fair staff and members, officials, car owners, drivers, participants, persons in the Restricted Area, promoters, sponsors, advertisers, owners and lessors of premises used to conduct the event (Releasees), and each of the undersigned RELEASES from all liability to the undersigned, their personal representatives, assigns, heirs, and next of kin for all loss of damage, and any claim or demands therefore, on account of injury to the person or property or death of the undersigned, whether caused by the negligence of Releasees or otherwise while the undersigned is in or upon the Restricted Area; and
2. HEREBY AGREES TO INDEMNIFY, RELEASE, AND HOLD HARMLESS the Releasees and each of them from any loss, liability, damage, or cost that they may incur due to the presence of undersigned in or upon the Restricted Area and whether caused by the negligence of the Releasees or otherwise; and
3. HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK of bodily injury, death, and property damage due to negligence of Releasees of otherwise while in or upon the Restricted Area; and
4. Each of the undersigned expressly agrees that this Release, Waiver of Liability, and Indemnity Agreement (Agreement) is intended to be as broad and inclusive as is permitted by Wyoming law and that if any portion of this Agreement is held invalid, the rest of this Agreement shall continue in full legal force and effect.
5. EACH OF THE UNDERSIGNED HAS READ AND VOLUNTARILY SIGNS THIS AGREEMENT, and further agrees that this Agreement represents the entire and integrated Agreement between the parties and supersedes all prior negotiations, representations, and agreements, whether written or oral. Wyoming law shall govern this Agreement, and the State of Wyoming expressly reserves its sovereign immunity. Venue for any dispute arising out of this Agreement shall be the First Judicial District, Laramie County, Wyoming.
